## Purpose

## Definitions

For the purposes of this Privacy Policy:

Cookies - are diminutive files deposited on your computer, mobile device, or any other device by a website, holding information about your browsing history on that site among various applications.

Device - means any device that can access the website such as a computer, a cell phone or a digital tablet.
